Intended Audience

This conference is designed for Principals, Assistant or Associate Principals, Deans of Students, Lead Teachers, Behavior Teams, Special Education Directors or Coordinators, and other school leaders.

Conference Goal

The conference will provide evidence-based information and practices to effectively work with students with behavior challenges and their families. Sessions will be tailored specifically for the needs of building leadership teams working to support positive student behavior, and meet the needs of students with behavioral challenges in their schools.

Why a Conference for School Leaders on “Behavior”?

Research is clear that the prevention of problem behavior and a positive school climate enhance the students' ability to learn. The contributions and support of principals and their leadership teams are crucial to establishing and maintaining a safe and orderly learning environment. School leadership teams need the knowledge and skills to support staff and students in behavior and discipline issues. To meet academic goals for our students and for our schools, improving and supporting the behavior of students in school is essential.

Keynote Presentations

The Importance of Systematic Screening for Behavior: What Every Administrator Needs to Know

Kathleen Lynne Lane, Ph.D., Professor of Special Education, University of Kansas, Lawrence, Kansas

Universal screening is an essential component of multi-tiered systems of support. This session will provide an introduction to Comprehensive, Integrated, Three-tiered (C3T) Models of Prevention, which addresses, academic, behavioral, and social domains, with an emphasis on the importance of systematic screenings. Several behavioral screening tools will be introduced, as will examples of how to use these data to (a) monitor overall levels of risk in a building and (b) connect students to Tier 2 and 3 supports.

Creating Safe & Healthy Schools: Common Myths, and Evidence-Based Strategies For Increasing Safety and Preventing Violence

Jeffrey R. Sprague, Ph.D., Professor of Special Education and Director of the University of Oregon Institute on Violence and Destructive Behavior, University of Oregon, Eugene, Oregon

Public schools have been profoundly shaken by a series of school shooting tragedies that changed the landscape of school security and destroyed the sense of relative safety that students, families, and educators have traditionally held about the schooling. Even though schools, compared to other social contexts, are one of the safest places for our children and youth, school settings are no longer regarded by our society safe havens. The goal of this session is to present state-of-the-art information and empirically supported practices which can make schools safe, and possible solutions in the local schools and communities to reduce school vulnerability to crime and violence.

1. Tips, Tools and Techniques: Helping Teachers Who Struggle with Classroom Management

Richard Van Acker, Ed.D., Emeritus Professor of Special Education, University of Illinois at Chicago, Chicago, Illinois

Across the nation, schools are being confronted by an increasing number of students who present challenging behavior. Most teachers feel ill prepared to address the demands for effective classroom discipline. This session will explore how administrators and team leaders can assist teachers who struggle with classroom management issues, and provide them with the guidance and support needed for them to improve. The session will identify some of the common errors teachers make in classroom management, and how these can be corrected. A number of empirically validated strategies and techniques that are useful for teachers at all levels to improve their classroom behavior management skills will be presented.

2. Policy and Legal Challenges in Meeting the Behavioral Needs of Students: Current and Emerging Issues

Carl Smith, Ph.D., Professor, School of Education, Iowa State University, Ames, Iowa

This workshop will focus on the challenges faced by administrators in determining the adequacy of various interventions for students with significant behavioral needs. Within this discussion will be an update on the implementation of discipline procedures required under IDEA 2004. Emerging issues will include meeting the needs of students with significant mental health issues and school-wide positive behavioral interventions and supports.

3. Learn, Execute, and Succeed: Strategies to Address Mental Health Issues in Children and Adolescents in the Schools

Patricia A. Lowe, Ph.D., Associate Professor, Department of Psychology and Research in Education, Kansas University, Lawrence, Kansas

This session will address the most common mental health problems, including Attention-Deficit Hyperactivity Disorder, Oppositional Defiant Disorder, Conduct Disorder, Depressive Disorders, and Anxiety Disorders, experienced by children and adolescents. School leaders will learn and develop a better understanding of these disorders. Pertinent updates on the Diagnostic and Statistical Manual of Mental Disorders, Fifth Edition (DSM5) will be discussed in relation to these common mental health disorders. School Leaders will also learn about effective strategies to implement and reduce the behavioral, social, and emotional issues children and adolescents with these mental health disorders experience.

Crucial Conversations: How to Talk with Teachers about Behavior Management

Moderator: Catherine DeSalvo, M.A., M.S.Ed., Principal, Wegner School, Boys Town, Nebraska

The panel members will include principals, a behavior specialist, and a special education director

Topics will include conducting a walk through that gives information about a teacher's behavior management style, coaching after observations, conducting formal and informal observations, giving corrective feedback, and reinforcing teachers who manage behaviors skillfully. Further discussion will include the role of teacher mentors and how to deal with teachers who bully.

What School Leaders Need To Know About...Court Decisions Related To Special Education Students With Challenging Behavior

Mark Ward, Legal Consultant, Early Childhood, Special Education, & Title Program Services, Kansas State Department of Education, Topeka, Kansas

This session will focus on the legal rights of children with disabilities to be educated in the least restrictive environment and to be afforded protections relating to disciplinary removals. It will address issues related to moving students due to behavior, including the important factors hearing officers and courts consider when an IEP team proposes to move a child with a disability to a more restrictive environment due to behavioral issues, or when school officials use the disciplinary removal option for students who either inflict serious bodily injury on another person or who possess illegal drugs or weapons.

Improving School Climate and Culture

Linda Geier, M.S., District PBIS Coordinator, Tulsa Public Schools, Oklahoma

Climate and culture are significant factors of a school's environment that can either impede or enhance learning. This session will clarify the difference between "climate" and "culture" and outline specific steps taken by one urban school district to enhance the capacity of schools to improve in these critical areas.

The Stool Has Three Legs: Providing Support for Teachers in Special Classrooms

Jim Teagarden, Ed.D., Associate Professor, Kansas State University, Manhattan, Kansas and Cooperative Response Colleague Team (CRCT)

The attrition of teachers of students who display significant behavioral concerns remains an ongoing concern for building leaders. This session will review the factors that have been identified that either lead to attrition or may reduce the issue. Central to reducing the attrition rate is the formation of peer support networks. Members of the Cooperative Response Colleague Team (CRCT) will present evidence that such peer support networks can increase morale, deepen professional development and improve the resources available for teachers and students.

Parent and Professional Partnerships: Six Steps toward Trust

Rud Turnbull, L.I.M., Professor, Beach Center on Disability, University of Kansas, Lawrence, Kansas

This session will describe the seven elements of parent-professional partnerships, review the data that support these steps, and offer a framework for practitioners.

Developing a Consistent School-wide System to Address Noncompliant and Disruptive Behavior

Terry L. Bigby, Ed.D., Missouri SW-PBS Tier 2/3 Consultant, Kansas City, Kansas and Cindy Scarbrough, M.S., Principal, Marysville Junior High School, Marysville, Kansas

Disruptive and noncompliant behavior manifests itself in many different ways in school settings. While these behaviors may look different, they have several common factors. This breakout session will provide school leaders with a conceptual model for effectively reducing and responding to disruptive and noncompliant behavior. Participants will take an in-depth look at how one school effectively developed consistent systems and practices and how this can be replicated in their settings.

Professional Development that STICKS: Improving Outcomes for Teachers and Students

Maura Linas, Ph.D. and Howard Wills, Ph.D., Associate Research Professor, Juniper Gardens Children's Project, University of Kansas, Kansas City, Kansas

Increasing numbers of students with special needs are being educated in general education classrooms. General educators report feeling unprepared to teach these students and manage challenging behavior in their classrooms. School Leaders will be introduced to a recently developed and tested high-quality professional development curriculum funded through an IES project. Professional Development that STICKS is designed to improve teachers' ability to improve classroom and behavior management for all students, including those with challenging student behavior.

Can Communication Really Help Improve Behavior?

Susan Bashinski, Ed.D. and Douglas Eicher, Ph.D., Associate Professors, Missouri Western State University, St. Joseph, Missouri

Presenters will discuss the relationship between learners' "problem behaviors" and a lack of basic communication skills. Although the session will review research that supports the existence of such a relationship, emphasis will focus on practical, communication-based strategies school personnel might implement to facilitate learners' positive behaviors. Ways in which building-level and district administrators might support teachers' implementation of evidence-based practices will, also, be included.
